I waive any and all claims I may now and in the future have against, and release from all liability and agree not to sue CYPRUS SKATING FEDERATION, their officers, employees, instructors, trainers (volunteer or other), agents, sponsors or representatives (collectively the "Released Parties") for any personal injury, death, property damages, expenses or loss sustained by me as a result of my participation in the above activities due to any cause whatsoever, including, without limitation, negligence, breach of statutory duty including duties arising from occupier's liability legislation, on the part of the Released Parties.

I am aware and acknowledge that CYPRUS SKATING FEDERATION does not provide any insurance coverage for its members, athletes, invitees, guests, visitors and participants to the activities and I am liable and I undertake the responsibility for all costs and expenses to insure myself and/or the minor participant, for any personal injury, health and medical care, death and

CYPRUS SKATING FEDERATION reserves the right to make changes to the present declaration and release of liability - waiver of all possible claims and assumption of risk and I agree with it, given a written notice is given to me in person or sent by email or sent by registered post at my above mentioned address.

This declaration and release of liability - waiver of all possible claims and assumption of risk, shall be governed by, construed and enforced in accordance with the laws of the Republic of Cyprus. The parties and/or participants hereby submit to the exclusive jurisdiction of the courts in Cyprus.
